**PARTICIPANT AGREEMENT, RELEASE, & ACKNOWLEDGMENT OF RISK**

In consideration of The BASS-JONS™ of Virginia, allowing me to participate in their Season Tournaments and Club Classic, I acknowledge and agree as follows:

- 1. I have read and understand the description of the tournament and the Official Rules of this Tournament season. I will obey all rules and understand that any violation may result in immediate disqualification without refund of my Entry fee.
- 2. I understand and acknowledge that competitive fishing is a dangerous sport, the risks of which include, though not exclusively, drowning, collisions in the water, and injuries from hooks and other fishing paraphernalia. I voluntarily assume responsibility for these risks, identified and not identified, and all risk of injury or death or damage to myself or my property or to others, including spectators and their property, arising from my participation in the tournament.
- 3. I hereby release, discharge, and agree to hold harmless and indemnify the BASS-JONS of VIRGINIA, its, officers, directors, the host, and tournament officials and its partners, demands, actions or rights of action which are related to, arise out of, or are in any way connected with my participation in this tournament, including specifically but not limited to the negligent acts or omissions of the BASS-JONS™ of VIRGINIA, its officers, directors, agents and tournament officials, and its partners, and all other persons or entities associated with the tournament from any and all liability, claims, entities associated with the tournament, for any and all injury, death, illness or disease, and other damage or loss to property suffered by myself or others.
